Annette Gutierrez, Executive Director for the Rio Grande Council of Governments, announced via telephone that Judge Cano has been appointed to serve on the Unified Scoring Committee and represent the Rio Grande Council of Governments area at

the pleasure of the Texas Agriculture Commissioner Sid Miller. She said the representative needed to be an Elected Official and needed to be residing in a non entitle community, which means that their population was less than 50,000. He was nominated in April. Ms. Gutierrez mentioned he is required to attend a meeting in New Braunfels on July 7, 2020, where the 24 representatives throughout the State of Texas will need to decide on what the scoring objectives will be for grant applications to the Texas Department of Agriculture in the coming year.
