Commissioner Colando moved to approve Section 14 on Monday, March 23, 2020 by 12:00 p.m. this declaration hereby mandates RV Parks/Campgrounds to close and vacate theirs guests through Thursday, April 2, 2020 unless the guests have established a primary place of residence at the designated rental location. Commissioner Esparza seconded the motion; motion passed unanimously.
